Sl. No.	The school is directed to ensure that :
1	The Composite science lab set up temporarily on tables. There are no work stations, and safety features like exhaust fan, fire extinguisher. A gas cylinder is seen on the floor which is hazardous for the students. The school should upgrade the lab in the light of the SoPs issued by the board vide circular no. 11 dated 04.10.2022 and submit the compliance within 3 months on SARAS portal.
2	The school should shift the Maths lab to a bigger room according to the size prescribed in the Affiliation bye laws and submit the compliance through videography within 3 months on SARAS portal.
3	The school should shift the Computer lab to a bigger room according to the size prescribed in the Affiliation bye laws and submit the compliance through videography within 3 months on SARAS portal.
4	The Library is 480 sq. ft which is not as per Affiliation Bye laws. The school should shift the library to a bigger room according to the size prescribed in the Affiliation bye laws and submit the compliance through videography within 3 months on SARAS portal.
5	The school should provide proper drinking water for the students and submit the compliance within 3 months on SARAS portal.
6	The school should upgrade the indoor/ outdoor sports facilities as per the SoPs issued by the board and submit the compliance through videography within 3 months on SARAS portal.
7	The school should construct a ramp or lift to access upper floor for CWSN students as per RPwD act 2016 submit the compliance through videography within 3 months on SARAS portal.
8	One CWSN toilet shown is very small as existing cubicle has been converted to CWSN toilets which is not navigable by wheel chair users/walkers. The school should construct CWSN toilets separately for boys and girls on every floor as prescribed in RPwD Act 2016 and Circular no. 5 dated 06.03.2023 issued by the board and submit the compliance through videography within 3 months on SARAS portal.

9	The school should ensure training of teachers with CoE Bengaluru and submit the compliance within 3 months.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school is required to renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

“The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms”.

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
